Phasing plans - moves for secure tenants

In the last newsletter we showed you which properties are in each of the three development phases. Here's some further information on how secure tenants in each phase will be affected. If you are a temporary tenant, please keep in contact with your Accommodation Officer, Rosaline Nolla to discuss your housing options. Her details are on the back page.



PHASE 1

1-45 Grange Farm Close1-18 Osmond CloseWork underway to prepare these for demolition this year

Secure tenants in these properties, have all been rehoused off-site or in phase 2 or 3 properties below. Off-site tenants will be offered a new home in the phase 3 development, due for completion in 2025.



PHASE 2

46-90 Grange Farm Close 19-27 Osmond Close 28-39 Osmond Close 1-63 Wesley Close We plan for all secure tenants in these phase 2 homes to move directly to the 68 new rental properties built as part of the phase 1 development, which is due for completion in 2021.



PHASE 3

40-64 Osmond Close 66-75 Osmond Close 109-118 Wesley Close 64-108 Wesley Close Secure tenants in phase 3 properties shown here will move directly to their new homes completed as part of the phase 2 development, which is due for completion in 2024.
