The Harrow (Parking Places) (Amendment No. 39) Traffic Order 2024

Made 28th November 2024

Coming into operation 13th December 2024

The Council of the London Borough of Harrow, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 45, 46, 49 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984(a) and of all other powers thereunto enabling hereby make the following Order.


1. This Order shall come into operation on 13th December 2024 and may be cited as The Harrow (Parking Places) (Amendment No. 39) Traffic Order 2024.
2. In this Order, the expression “enactment” means any enactment, whether public, general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Harrow (Parking Places) Traffic Order 2020(b) shall have effect as though
 - (a) for the item numbered 9 in Table 1 to Part 3 of Schedule 1 to that Order there were substituted the item similarly numbered and set out in the Schedule to this Order;
 - (b) for the item numbered 14 in Table 1 to Part 3 of Schedule 12 to that Order there were substituted the item similarly numbered and set out in the Schedule to this Order;
 - (c) for the item numbered 6 in Table 1 to Part 3 of Schedule 25 to that Order there were substituted the item similarly numbered and set out in the Schedule to this Order;

- (d) for the item numbered 3 in Table 1 to Part 3 of Schedule 58 to that Order there were substituted the item similarly numbered and set out in the Schedule to this Order
