The Harrow (Free Parking Places) (Disabled Persons) (Amendment No. 19) Traffic Order 20224

Made 28th November 2024

Coming into operation 13th December 2024

The Council of the London Borough of Harrow, after consulting the Commissioner of Police for the Metropolis, in exercise of the powers conferred by Sections 6, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984(a), as amended by the Local Government Act 1985(b), and of all other powers thereunto enabling, hereby make the following Order:-

1. This Order shall come into operation on 6th December 2024 and may be cited as The Harrow (Free Parking Places) (Disabled Persons) (Amendment No. 19) Traffic Order 2024.
2. In this Order, the expression “enactment” means any enactment, whether public, general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Harrow (Free Parking Places) (Disabled Persons) Order 2017(c) shall have effect as though:-
 - (a) there were added to Schedule 1 to that Order the items numbered 228 to 241 and set out in columns 1 and 2 of Schedule 1 to this Order;
 - (b) there were added to Schedule 2 to that Order the item numbered 2 and set out in columns 1, 2, 3 and 4 of Schedule 2 to this Order.

SCHEDULE 1

Item No.	Location
228	ALEXANDRA AVENUE The service road fronting Nos. 302 to 332 Alexandra Avenue, the north-east side from a point 0.60 metres north-west of a point opposite the north-western flank wall of No. 302 Alexandra Avenue north westward for a distance of 6.60 metres.
229	BYRON ROAD The west side, from a point opposite the common boundary of Nos. 230 and 232 northward for a distance of 5.50 metres.
230	CECIL ROAD The south-west side, from a point 0.70 metres northwest of a point opposite the common boundary of Nos. 17 and 19 Cecil Road south eastward for a distance of 5.50 metres.
231	CHIGWELL HURST COURT the south-east side, from a point 0.60 metres south-west of a point opposite the north-eastern flank wall of Nos. 9 and 10 Chigwell Hurst Court south westward for a distance of 6.60 metres.
232	COLES CRESCENT The north side, from a point 0.70 metres south-west of a point opposite the common boundary of Nos. 53 and 55 Coles Crescent westward for a distance of 6.60 metres.
233	COURTENAY AVENUE The service road fronting Nos. 35 to 43 Courtenay Avenue, the west side from a point opposite the common boundary of Nos. 39 and 41 Courtenay Avenue southward for a distance of 6.60 metres.
234	EASTCOTE AVENUE The west side, between a point 1.40 metres south of a point opposite the common boundary of Nos. 18 and 20 Eastcote Avenue and a point 5.20 metres north of a point opposite that common boundary.
235	OAKINGTON AVENUE The north side, from a point 8.90 metres west of the western kerb-line of The Drive to a point 15.50 metres west of that kerb-line.
236	PINNER VIEW The north-west side, from a point opposite the common boundary of Nos. 20 and 22 Pinner View to a point 6.60 metres south-west of a point opposite that common boundary.
237	STONEGROVE GARDENS, THE NORTHERN ARM The south-east side, from a point 0.30 metres south west of a point opposite the south western flank wall of No. 68 Stonegrove Gardens south westward for a distance of 5.10 metres.
238	TEMPLE MEAD CLOSE The east side, from a point opposite the southern flank wall of No. 22 Temple Mead Close southward for a distance of 5.50 metres.
239	TYRELL CLOSE The south side, from a point opposite the common boundary of Nos. 6 and 7 Tyrell Close eastward for a distance of 6.60 metres.
240	VAUGHAN ROAD The north side, from a point opposite the common boundary of Nos 34 and 36 Vaughan Road westward for a distance of 6.60 metres.
241	VAUGHAN ROAD The north-west side, from a point opposite the common boundary of Nos. 112 and 114 Vaughan Road to a point 6.60 metres north-east of a point opposite that common boundary.

EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport)

The Harrow (Free Parking Places) (Disabled Persons) Order 2017 designates parking places in the London Borough of Harrow in which disabled persons' vehicles which display in the relevant position a disabled person's badge issued in accordance with the provisions of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 may be left. The provisions of the Order of 2017 are applied to other similarly designated parking places within that Borough.

This Order designates additional parking places and applies the provisions of the Order of 2017 to the parking places so designated.
