#### **Phase 1 Heating System**

## To ensure the heating system is switched on you must keep the Heat Interface Unit (HIU) switched on at all times.

The HIU switch is located in the airing cupboard, where the meter is located. If you need advice, contact your Housing Officer, Rita Contractor (see back page).


#### The consequences of turning the HIU off

Not switching on the heating system will likely cause an airlock making the heating system inefficient and likely to only heat part of or none of their home. To correct the problem an engineer will need to be called to fix the problem. This is classified as 'user misuse', and the cost will have to be paid by the resident.

The HIU when switched on will not heat the home until

you turn the thermostat dial above the room temperature. However, it will provide hot water to the home, and this will incur a small cost depending on how much hot water is used.

The Council's gas contractor is ThermoServe and they have been conducting maintenance checks to the MVHR system and HUI - see MVHR photo.



12 month "End of Defect" inspections to Phase 1 homes, including all communal areas, are now complete. Higgins are making good all reported defects and anticipate completion by Mid December. Once all the defects to your home are completed, please sign the form Higgins issued you, confirming all defects have been completed satisfactorily. Any **new repairs** will now need to be reported to Access Harrow who will instruct United Living to attend.

#### Fly tipping fines

Fly tipping fines have recently increased from £400 to £1000 and the Council enforcement team is expanding. All boxes must be broken down and recycled appropriately. Other large items must be taken to the tip or disposed of by booking a free bulky waste collection (up to 4 large items once per year).



#### Regeneration plans - Phase 2a

The original outline planning consent for the later development phases has lapsed and the Council has recently assembled a Design & Technical ('D&T') project team to work up and submit new planning applications.

To meet funding deadlines, the Council will accelerate the delivery of the next phase through a detailed application for about 50 new homes in what we call 'Phase 2a'. This will include social rented homes for the remaining secure tenants on the estate.

The plan below shows the anticipated location of Phase 2a, outlined in red. Blocks for demolition are subject to survey/inspection but will need to facilitate access to and construction of the new buildings. The existing site compound will be used by the demolitions and main works contractor.



Consent to enable the demolition works will be obtained through a process known as Prior Approval and residents will soon see notices up around the site/receive letters about this. We will also start working with you on the consultation process to support the planning application for Phase 2A.

It is anticipated that demolitions will commence in February/March 2025.

At the same time, we will work up a masterplan for the remaining development phases and again, we will engage with you as part of the consultation for this.

The Council – along with members of the D&T team – will be attending the November Resident Steering Group to commence the consultation process and set out indicative proposals and programme for Phase 2A and the wider masterplan.
